### STATEMENT OF SUPPORT OF MEMBERSHIP

I, the undersigned, Professor Camelia Toader, PhD, titular member of the International Academy of Comparative Law and head of the Romanian National Committee, hereby support Mr. Manuel Guțan, PhD, Professor of Romanian Legal History and Comparative Law at the *Lucian Blaga* University of Sibiu (LBUS), Romania, to become an associate member of IACL.

First and foremost, I have noted Professor Guțan as the Editor-in-Chief of the Romanian Journal of Comparative Law (RJCL). Launched in 2010 and published in English and French, it became a leading Romanian legal journal with international visibility and scientific impact. Under Mr Guțan's editorship, RJCL not only succeeded in giving Romanian legal research a strong comparative touch but also could do this by approaching a wide range of Comparative Law topics and applying different Comparative Law methodologies (classical and post-modern). Many young Romanian legal scholars discovered in RJCL a welcoming scientific tribune and, generally, a solid Romanian academic network promoting comparative law research that has constantly grown around this journal in the last few years. Mr Guțan has distinguished himself through a series of contributions published in its issues, e.g. *Comparative Law in Romania: History, Present and Perspectives* (vol. 1/2010), *Romanian Semi-presidentialism in Historical Context* (vol. 3/2012) *The Weaknesses of the Romanian Constitutional Tradition or a Constitutional Present in Quest for a Constitutional Past* (vol. 5/2014), *The Legal Transplant and the Building of the Romanian Legal Identity in the Second Half of the 19th Century and the Beginning of the 20th Century* (vol. 8/2017). I've established a strong collaboration with RJCL and have the pleasure of being one of its scientific board members. Last but not least, the Romanian national committee of IACL is developing a close collaboration with RJCL. Professor Guțan was very helpful in selecting a qualitative group of Romanian national rapporteurs for the IACL 2018 Congress held in Fukuoka (Japan), and the 2022 Congress held in Asuncion (Paraguay).

Besides, Professor Guțan has undertaken fruitful research in Comparative Law, Comparative Constitutional Law, and Comparative Legal History materialised in articles, chapters and books published in prestigious national and international legal journals (e.g. *The Journal of Comparative Law, Glossae, European Journal of Legal History, Journal of Constitutional History, Revue de droit international et de droit comparé, Romanian Public Law Review, Romanian Private Law Review, Pandectele Române, Dreptul*, etc.) and with prestigious national and international publishing houses (Routledge, Hart Publishing, Springer, Duncker & Humblot, LGDJ, Schulthess, Vittorio Klostermann etc.). Interestingly, the candidate has proven advanced methodological skills by intermingling legal history and comparative law methodologies in an interdisciplinary scientific approach. His research focuses on a wide spectrum of comparative law and comparative legal history topics. Still, Professor Guțan's main contribution lies in the field of legal transplant and its connecting subject matters, e.g. legal culture and legal identity. This research was developed especially in his seminal monograph *Constitutional Transplant and Constitutionalism in Modern Romania 1802-1866* [Transplant constituțional și constituționalism în România modernă 1802-1866, Hamangiu, București, 2013] where he reassesses the Romanian constitutional history scholarship from a completely different scientific angle, balancing the causes, models, methods and mechanisms of the constitutional transplant that occurred in the Romanian Principalities/state in the 19<sup>th</sup> century against their positive or negative effects in the Romanian constitutional order and society. Above all, many would remark on his original analyses of the Romanian intellectual debate, developed in the second half of the 19<sup>th</sup> century and the first half of the 20<sup>th</sup> century, about the general and frequently negative phenomenon

of legal transplantation (surnamed the debate of forms without substance), which the candidate is refining in his theory about "the Romanian epistemology of the legal transplant". His comparative and historical methodological angles were also fructified in articles dedicated to contemporary Romanian constitutional law, especially on presidential powers and constitutional identity.

Last, I should mention Professor Guțan's skills in teaching comparative law and conducting postgraduate research in this academic area. Since 2016, he has been conducting PhDs in Comparative Legal History at LBUS, and his PhD students are researching legal history using comparative law methodology. Relevantly, Mr. Guțan is teaching the advanced course in comparative law methodology at the doctoral school of LBUS. At the undergraduate level, he teaches the introductory course in the General Theory of Comparative Law (second grade). Remarkably, in 2014, Professor Guțan published a Comparative Law Handbook (Comparative Legal Systems. General Theory of Comparative Law, Hamangiu, București) with a unique approach in the Romanian comparative legal scholarship, focusing both on the classical and post-modern matters of comparative law. The handbook synthesises his research in comparative law, especially his contribution to legal transplants.

For his significant contributions to the Romanian and international comparative law and comparative legal history scholarship, for his unwavering commitment to developing comparative law studies in Romania, and for his comprehensive work in the field of comparative law, I am convinced that Mr. Manuel Guțan, Professor at Lucian Blaga University of Sibiu, Romania, is an ideal candidate for associate membership of the International Academy of Comparative Law.
