**Re: Nomination of Professor Irene Calboli as an Associate Member of the International Academy of Comparative Law**

Dear Secretary-General,

I am pleased to nominate Dr. Irene Calboli, Regents Professor at Texas A&M University School of Law, to become an Associate Member of the International Academy of Comparative Law. Dr. Calboli's highly distinguished scholarship, teaching, and service have played a critical role in promoting Comparative Law, especially in the areas of Intellectual Property (IP) and Trade Law, not only in the United States (U.S.) and Europe but also in Asia-Pacific, Africa, and Latin America. I cannot think of a better candidate to be elected as one of the new Members of our Academy. In addition, I should note that Dr. Calboli has already offered her excellent service to the Academy on two specific occasions: as U.S. national Co-Rapporteur for the 2024 Paris Congress' theme "Comparative Law Teaching" and as U.S. Rapporteur for the 2022 Asuncion Congress's theme "Legal Perspective on the Streaming Industry."

Dr. Calboli moved to the U.S. from Europe in 2002 after completing her Doctorate in IP and Competition Law. In the past two decades, she has become one of the most prominent IP authorities in the U.S. She also regularly teaches and visits universities on every continent. To cite a few, she holds honorary positions in institutions in Singapore, India, Indonesia, Australia, Switzerland, France, Poland, Italy, Spain, Argentina, and Israel. In 2021, she was Fulbright Distinguished Chair in Law and Economics at Hanken School of Economics in Finland after serving as a Fulbright Specialist in Cambodia in 2018. Unquestionably, she represents a living embodiment of "comparative law in action," a scholar who spends considerable time in foreign jurisdictions and implements comparative legal analysis in most of her research, teaching, and professional engagements. A brief review of her Curriculum Vitae shows that her interest in comparative law started when she was still an undergraduate at the University of Bologna. In the following years, she had the opportunity to study and work in institutions across multiple jurisdictions and different legal traditions. This firmed her interest in the subject, which has since accompanied and defined every aspect of her career.

Today, Dr. Calboli is a dedicated and award-winning teacher and a widely cited author. She has published eleven books, over 100 scientific articles, book chapters, and policy reports with the most prestigious publishers and in high-ranked peer and law reviews. Her articles have been re-published in specialized treatises and anthologies, featured in textbooks and class materials on every continent, and translated into Spanish, French, Chinese, Arabic, and Russian. Besides writing on substantive IP law

topics—from a national, comparative, and international perspective—she also focuses on research methodologies emphasizing the importance of comparative law. In particular, she has advocated for strengthening comparative legal analysis in the U.S. in her article, *A Call for Strengthening the Role of Comparative Legal Analysis in the United States* (90 St. John's L. Rev. 609 (2016)). She additionally emphasized the important role of comparative law as one of the most relevant research lenses for IP scholars in the *Handbook of Intellectual Property Research*, which she published (open access) with Oxford University Press in 2020.

Because of her distinguished record and expertise, Dr. Calboli is regularly invited as an expert to international and regional organizations, such as the World Intellectual Property Organization (WIPO), the World Trade Organization (WTO), the U.S. Conference for Trade and Development, the European Union, the African Regional Intellectual Property Organization, and the Association of Southeast Asia Nations. In these fora, Dr. Calboli has additionally demonstrated her strong commitment to comparative law by promoting large professional conferences for academics, policymakers, and the private sector in Asia, Europe, Africa, and South America. These conferences, organized with WIPO and WTO, include the IP and Innovations Researchers of Asia Network and Conference (IPIRA, established in 2018), the IP Researchers of Europe Conference (IPRE, established in 2018), the IP Scholars Africa Conference (IPSA, established in 2018), and the IP and Innovation Researcher of Latin America Conference (IPILA, established in 2022). It was also Dr. Calboli's idea to expand the successful WIPO-WTO Colloquium, which takes place annually in Geneva, to regional editions. She co-organized the first WIPO-WTO Asian Regional Colloquium in 2017 and assisted in the 2018 and 2024 editions of the WIPO-WTO African Colloquium.


As mentioned, Dr. Calboli is a highly respected member of the academic community at the national, regional, and international levels, and it would be a privilege to have her as part of our Academy. Besides being part of the editorial boards and advisory committees of several prestigious publications, she is an elected member of the American Law Institute and the European Law Institute, and her law school is an institutional member of the Asian Law Institute. She serves on the board of the European Policy for Intellectual Property Law Association (EPIP), as an editor for the American Society of Comparative Law, co-chair of the International Commercial Law Committee of the American Branch of the International Law Association, and until 2023 was a member of the Council of the Singapore Branch of the International Law Association. She is also the current Chair of the Comparative Law Section of the Association of American Law Schools (AALS), a past Chair of the East Asia Law and Society Section, and the Chair-Elect of the European Law Section. In all these roles, she has organized important scholarly efforts, including conference panels and works-in-progress events for scholars to discuss their research, always with a prominent focus on promoting research and teaching related to comparative law. This Fall, she is working as the main local organizer for the Annual Meeting of the American Society of Comparative Law.

**Irene Calboli** specializes in International and Comparative Intellectual Property, International Trade, and Cultural Heritage Law. She is Regents Professor of Law at Texas A&M University School of Law and holds several honorary and visiting academic appointments, including at Melbourne University, Singapore University of Social Sciences, National Law University Delhi, SciencesPo Paris, the University of Geneva, Bocconi University, and Stanford University. In 2022, she was a Fulbright-Hanken Distinguished Chair in Business and Economics in Finland and, in 2018, a Fulbright Specialist in Cambodia. A renowned expert in her field, Irene regularly advises international and regional organizations, national governments, and Intellectual Property offices on topics related to economic development, sustainability, and innovation policy. She has published 11 books and more than 100 articles, book chapters, and policy reports, which are highly regarded and cited by policymakers, judges, and practitioners and have helped shape legislative reforms at the international, regional, and national levels. Her ideas were instrumental in creating, in collaboration with the World Intellectual Property and the World Trade Organization, the “IP and Innovation Research of Asia Network” and the “IP Researchers Europe Conference,” two networks dedicated to facilitating interactions between academics and policymakers in Asia and Europe. She additionally contributed to similar research networks in Latin America and Africa. Irene is an elected member of the American Law Institute and the European Law Institute, where she serves as co-chair of the Intellectual Property Group. She is the current Chair of the Comparative Law Section of the American Association of Law Schools, the past Chair of the East Asia Law and Society Section, and the Chair-elect of the European Law Section. She also serves in leadership roles for the American Branch of the International Law Association, the European Policy for Intellectual Property Law Association, and the International Trademark Association. Irene is a graduate of the University of Bologna, Queen Mary University, and the London School of Economics. She is fluent in English, French, Spanish, and Italian, and has a working knowledge of German.
