

Professor Alessandra De Luca is an associate professor of private comparative law at the University of Florence. She has completed her studies under the supervision of Prof. Vittoria Barsotti, who is titular member of the International Academy of Comparative Law since a long time.

She has gained the “Abilitazione nazionale” to become Full Professor of Private Comparative Law and she is now waiting to be “called” on this new position.


She has developed important research in the field of legal education with a particular focus on legal clinics and the possibility of adapting this tool to Italian Universities.

Her research ranges from consumer’s protection to the role of mediation in Italy, taking care of analyzing the impact of EU legislation on the law of the different member States and developing a rigorous comparative law analysis with common law countries.

Her focus on procedural aspects in comparative law analysis have made her known for her insight and attention to *legal process* issues.

Her attendance at comparatists' conferences is assiduous, both in Italy and abroad. In particular, she has already taken part in the work of the International Academy by participating to the Congress that took place in Asuncion (*The Costs of Access to Justice in Italy*, in *Italian National Reports to the XXIst International Congress of Comparative Law*, Asunciòn, 145-169).
