Dear President, dear Secretary General, dear Secretariat of the International Academy of Comparative Law,

In my capacity as Titular Member of the AIDC-IACL, I am writing to propose that Professor Marco Torsello, a current Associate Member of the Academy, be awarded the position of Titular Member.

Marco is a full professor of Comparative Law at the University of Verona School of Law, where he teaches Comparative Private Law and Transnational Commercial Law. He is also a Global Professor of Law at NYU School of Law, Law-Abroad Program in Paris, where he has taught European Business Law since 2014, and a Visiting Professor at the Université Sciences Po, École de droit, where in the fall of 2024, he is teaching Introduction to Contract Law.

As Marco's CV and List of Publications, both attached to this proposal, demonstrate, he is an active scholar in the field of comparative law, focusing not only on the traditional areas of interests of comparative lawyers but also on more practice-oriented areas of comparative and transnational law, including the process of unification of civil and commercial law through conventions or harmonization through model contract clauses and other soft law instruments, as well as the role of comparative law in cross-border dispute resolution.

Marco has also been a very active Associate Member of the Academy.

In effect, he attended all the General Congresses starting from the one held in Utrecht in 2006 (with only one exception in 2018, due to personal reasons), and most Thematic Congresses. He has presented papers, which were subsequently published, as the Italian National Reporter, at the 2008 Thematic Congress in Mexico City (*The Impact of Uniform Law in National Law. Limits and Possibilities*), the 2010 General Congress in Washington D.C. (*Financial Leasing and Its Unification by UNIDROIT*); the 2014 General Congress in Vienna (*The Effects of Financial Crises on the Binding Force of Contracts: Renegotiation. Rescission or Revision?*), the 2022 General Congress in Asunción (*Independence and Impartiality of Adjudicators*). He will also be presenting on the occasion of the forthcoming Thematic Congress in Paris, in November 2024 (session on the *Teaching of Comparative Law*).

In the context of the 2022 General Congress in Asunción (Paraguay), Marco edited with Michele Graziadei the "Italian National Reports to the XXIst International Congress of Comparative Law – Asunción 2022", which were published in the Law Series of the University of Verona School of Law and were among the few collections of National Reports that had already been published at the time of the Congress in Asunción.

In 2019, Marco responded to the call for papers on the occasion of the launch of the IUS COMPARATUM JOURNAL, on the topic of "The Use of Comparative Methodology in International Arbitration". Marco's paper (A New (Quasi-)Codified Lex Mercatoria Based

on Soft Law Regulatory Competition and the Use of Comparative Law Methodology in International Commercial Arbitration) was selected and published in issue no. 1/2020 of the Journal.

Finally, in 2022, Marco was one of the five members of the Nomination Committee in charge of submitting to the Executive Committee the proposals for the new President, Secretary General, and Vice-Presidents of the Academy.

In addition to all the above objective facts, let me add a personal comment by saying that I have known Marco very well personally and professionally for almost thirty years and I am absolutely confident that he would be honored to become a Titular Member of the Academy and would take the new position very seriously, devoting time and energy to the the activity of the Academy.

For all the above reasons, I hereby propose and wholeheartedly support the candidacy of Marco Torsello as a Titular Member of the International Academy of Comparative Law.
