Dear Secretary-General, dear Colleague,

In my quality of Chairwoman of the Czech branch of IACL I would like to recommend assoc. prof. Václav Stehlík as the candidate for Associate Member of International Academy of Comparative Law.

I have known Václav Stehlík since the early years of his career of EU law lecturer and researcher at the Department of International and European Law, Faculty of Law, Palacký University in Olomouc, Czech Republic. He gradually held the position of lecturer, senior lecturer and now of associate professor and Jean Monnet Chairholder in EU law. Next to it, for several years he was appointed in the position of the Head of this department, now he serves his second term as the Dean of this Law school.

His lecturing as well as research focus on various issues of EU law and its application in Member States, functioning of internal market, migration rules with a special focus on the preservation of the best interests of the child, EU external relations rules as well judicial enforcement of supranational regulations and role of national judiciary with a special focus on supreme and constitutional courts. The same is valid for post-gradual courses and formation of Ph.D. students coming both from the Czech Republic and abroad. He has several successful Ph.D. graduates and supervises a number of students, several of them approaching at the end of the studies.

Finally, I would like to underline Václav's responsibilities and work in expert bodies such as Ph.D. committees, Scientific Councils of Law Faculties in the Czech Republic and Slovakia, professional organizations, research groups/networks, and several editorial boards of law journals including *Scopus* indexed.
